12. PUBLIC SESSION:

NJ published an App - Covid19 dashboard which will provide additional Covid reflated information.

Ilene Paskanik, Teacher at MHS said I understand wearing masks are imperative. But we are asked to wear masks in the classroom while teaching remotely

Dr. Schneider said it is taking time to get used to it. Mantra: All masks-all the time in the office. There are others moving around. We never know who we will come across. The aerosol has a cumulative effect.

Ms. Paskanik replied it is not about the time we are with the students.

Tina Jablonski, Teacher at JFC said she worked a partial day while no students.

Lisa Vena asked are we speaking of remote learning? If not in classroom, why the need for a mask?

Dr. Schneider said we cannot give choices on mask wearing.

Ms. Donnelly clarified that we are discussing masks wearing October 19 - 26, 2020 when staff are back to prepare for the students return.

Lisa Pusillo, Teacher at JFC, I do not understand why we are waiting for a week before assistants. Can it be reconsidered?

Dr. Schneider stated the reason is from an IT perspective to ensure we can work remotely from the classroom.

Ms. Pusillo replied we need them to help with the set up. We are in complete support of Ms. Bigos's idea to have full classes in full days in person. In the afternoon students are tired.

Leah Housel, Teacher at JFC said my own children were exposed. We need a protocol on how to handle these situations.

Dr. Schneider said the nurses are trained.

Anne Marie Nolan, Occupational Therapist at MHS is concerned with the communication. She suggested using robo call system to inform families.

Maureen Welsh, Teacher at MHS wanted to acknowledge Kris Gould, Supervisor at MHS for all of his efforts since March to present and are grateful for him and applaud him

Cindy Galloway, Teacher at MES read a statement (attached).

Dr. Schneider responded you are with Leah Pray and I. We discussed this to bring back in a succession so teachers can prepare. This is why we decided to come back over time. The heads of the unions met with administration to put a plan in place.

Leah Pray, President MCSSETA reported all of this information has been shared with the building principals by me, Dr Schneider, Tina Jablonski, and Deborah Donnelly. I will address at a meeting once the healthcare information comes out. Please reach out to the building principals and copy me and Dr. Schneider.

Dr. Schneider followed up by saying there is a letter going out tomorrow to parents regarding masks, temperature checks and lunch. It will be on District Announcements for our staff to see the communication.

Ms. Jablonski said we have building meetings and speak to building principals. Not cohesive with the District.

Clara Bigos, Principal at JFC said we are accommodating our students.

Ms. Jablonski said we know that is who our children are. Spoke to nurses regarding those that cannot wear masks. Will we be able to get N95 masks? I am not feeling secure.

Dr. Schneider said I will take a look at this with Ms. Donnelly regarding PPE. CS teachers needing face shields, needs will differ. Ms. Bigos can collect your PPE concerns.

Lori Cuddy, Teacher at MHS said only our District is not back full time. Have we looked at the other districts and what they are doing with this population?

Dr. Schneider responded yes, we do know the concerns and we anticipate different teachers needing different types of PPE. We will look at those needs when we see who/how many are returning to your classroom.

Ms. Cuddy said I commend the decision to return as hybrid. The sending districts are open to special education. I am concerned they will not continue to send their students to us.

Dr. Schneider responded Remember, in the past, we managed the H1N1 protocols with our local department of health and education Our Nurses reported our incident rates weekly to the department of health. For those

who were not here then, we did a great job. Congratulations to all our staff then, because we reported zero cases of flu the entire spring semester. We did a great job then and we can do it again!

Karen Burke, Nurse at MHS reported the Burlington County Special Services School District has been back in session 5 full days a week. I am in touch with the school nurse weekly. Things are going well. Communication is important, nurses feel it is important that we go back safely. All the nurses are working together. Last year we complained about how bad the high school looked. The work has been done, thank you for the school being painted and the new floors!

My name is Cindy Golway, and I am a teacher at Mercer Elementary School.

The fun fact about my journey to MCSSSD is that I have known that I have wanted to work here since the time I was in second grade as my cousin went through our district.

Why do I share this?

2 reasons-

- 1. my hard work and dedication to this district comes from the heart! I love this place and the population I work with day in and out.
- 2. I have second grader of my own who I have chosen to keep remote because of the mask wearing rules and knowing how hard it is.

Planners!

Teachers are planners!

Planning Started in the second grade to get myself her to my dream job!

Planning how possible to care for my family while going back into the classroom to do my job.

Goodbye snuggles with my daughter. Goodbye contact with my elder parents. As I return to the classroom with students who may be unmasked.

But this all ties back to many unanswered questions with the opening of our building.

Things that I usually do without blinking an eye caring for my students but now an uneasy sense of how to do it while social distancing.

Example you may ask? Sure

Changing a student who has wet themselves but wears high top sneakers because they have difficulty keeping shoes on.

Or the child who defecates and it takes two staff members to clean and change? Suggestions welcome on how to do this whole social distancing.

What's the plan and protocol for aggressive students?

Those students run away when not held onto them?

MASK?

Who wears them? How do they keep them on?

Let's talk promoting and the bases of an ABA program. Hands on. Touching? How can we do this? How can we guide and show without touching?

Cleaning protocol? What is that going to look like? What Exactly does a "deep clean" look like instead a nightly cleaning?

Hand washing needs to be added to the schedule. How are our students expected to do this on their own? Many in our population needs promoting to clean hands and now just play with water, soap if we are lucky.

What does feeding look like in the classroom? Is there 6-foot silverware being invented I do not know about?

I had to say something, I had to speak up because I am losing sleep. I have a constant knot in my stomach. I want to be in my routine! With my colleagues. Doing what we do best.

Because if you think teachers think outside of the box you should see what we have done teaching virtually. Just as much as we are adjusting to teaching in this environment we are also learning on our own with limited guidance.

Teachers are resultant humans who love other people's children like they are our own, but please make it safe! Please keep us safe so we can keep loving our own children.

We want answers, so we feel safe. It is not that we don't want to go back in our work home.
