The monthly business meeting for the month of June 2021 was held this day in the Mercer Elementary School Gymnasium, 1020 Old Trenton Road, Hamilton, NJ.

1. **CALL TO ORDER:** Board of Education President Camille Rainiero called the meeting to order at 4:30 pm.
